"Flea markets", raffles and explicit products are not allowed. **Submitting an application to be a vendor does not guarantee that you will be allowed to sell at our event.** We try our best to limit the number of similar products that are sold so our vendors have a successful event.

Vendors must provide their own tent or cover, chairs and tables. The AV BBQ Battle is only providing you the space to sell your goods to our guests. You may begin setting up your location on the Friday of our competition starting at 12 noon. Locations are not preassigned and are on a first come, first served basis. You are encouraged to setup your space before 6 p.m. Friday and we hope that you will stay through Saturday afternoon. After 6 p.m. Friday our BBQ competition and music will be taking place and setup becomes very difficult with our crowds. No vehicles or trailers are allowed on the courthouse lawn without prior approval.

The community, the city of Ironton, Iron county and the Arcadia Valley BBQ Battle and its committee members will not be responsible for the safety or security of your property. No security is provided through the night.

This is a rain or shine event and will be held regardless of weather. No refunds will be made after June 1.
